"Win a weekend at the Capitole in Quebec City" Contest RULES AND REGULATIONS

CONTEST PERIOD

1. The "Win a weekend at the Capitole in Quebec City" contest is organized by Compagnie France Film (hereafter referred to as, the "Contest Organizer"). The contest begins on May 28, 2015 at 9AM EST and ends on July 11, 2015 at 9PM EST (hereafter referred to as, the "Contest Period").

ELIGIBILITY

2. To be eligible for the contest, each participant must be a Canadian resident and be of legal age in his/her province of residence (hereafter referred to as, the "Eligible Participant" or the "Participant"). Participants must be at least 18 years of age at the time of entering the contest. Employees, agents and representatives of the Contest Organizer, its subsidiaries and affiliates, its advertising and marketing agencies, suppliers of materials, prizes and services related to the present contest, and all other parties directly related to the holding of this contest, as well as all members of their immediate family, including any legal or common law spouses, mothers, fathers, brothers, sisters, children and any other persons living with said employees, agents and representatives, are not eligible to enter the contest.

HOW TO PARTICIPATE

3. No purchase is necessary. To enter the contest, an Eligible Participant must complete the contest entry form, which can be found on the Théâtre St-Denis website (www.theatrestdenis.com).

4. Limit

There is a limit of one contest entry per Eligible Participant during the Contest Period.

PRIZE DESCRIPTION

- 5. One grand prize will be awarded, consisting of one (1) weekend getaway at the Capitole de Québec for two (2) persons on September 4-5, 2015. The prize includes:
 - Two (2) nights of accommodations at the Capitole de Québec in a Deluxe room (with whirlpool tub) on September 4-5, 2015
 - Two (2) breakfasts
 - One (1) pair of tickets for a dinner-show performance of "Elvis Experience, with Martin Fontaine" in the Théâtre Capitole on September 5, 2015 (alcohol not included with meal)

The total approximate value of the prize is \$952 CA. Transportation from the winner's residence to the Capitole du Quebec, as well as parking at the hotel, is not included in the prize. Any other expenses not described herein are understood to be the sole

responsibility of the winner. This prize is non transferable, cannot be exchanged for cash value and cannot be rescheduled should the winner not be available on September 4-5-6, 2015.

SELECTING THE WINNER

- 6. The winner will be selected by a random draw from the pool of all eligible contest entries received during the Contest Period. The draw will take place in the offices of Compagnie France Film on July 13, 2015 at 1PM EST. The winner will be contacted by telephone or email.
- 7. An Eligible Participant's chances of winning will depend on the number of eligible contest entry forms received during the Contest Period.

GENERAL CONDITIONS

- 8. To be declared a winner, the Participant must:
 - 8.1 Be at least 18 years of age when they entered the contest;
 - 8.2 Have completed a contest entry form and provided all required information;
 - 8.3 Be reachable by the Contest Organizer via email or telephone, at the Contest Organizer's discretion, within two (2) business days following the random draw. If it is impossible to reach the selected Participant within two (2) business days following the random draw, the Participant loses any right to claim the prize and another contest entry form will be selected by a random draw. If it is impossible to reach the second (2nd) selected Participant via email or telephone within two (2) business days following the second (2nd) draw, the second Participant loses any right to claim the prize and a third contest entry form will be selected by a random draw. If it is impossible to reach the third (3rd) selected Participant via email or telephone within two (2) business days following the third (3rd) draw, the prize will be cancelled;
 - 8.4 Complete and sign the liability release form (hereafter referred to as, the "Release Form"), which will be sent to the winner by the Contest Organizer via email or fax, at the Contest Organizer's discretion, and send it back to said Contest Organizer within forty-eight (48) hours of receiving said Release Form; and,
 - 8.5 Be available on September 4-5-6, 2015. Should the selected Participant be unable to respect any of the conditions listed above or any other rules and regulations stated in the present document, the selected Participant will be disqualified and lose the prize.

- 9. Claiming the prize. In the forty-eight (48) hours following reception of the Release Form, the Contest Organizer will send the winner a letter with instructions on how to claim his/her prize. Should the selected winner refuse the prize, the Contest Organizer is freed from all obligations regarding the awarding of said prize and may proceed, at their discretion, to cancel the prize or draw another eligible contest entry using the same process as described above.
- 10. Verification. Contest entry forms and Release Forms may be subject to verification by the Contest Organizer. All contest entries or Release Forms that are incomplete, incorrect, illegible, reproduced by hand or mechanically manipulated, fraudulent, obtained from a non-authorized source, submitted or sent late, bearing an invalid telephone number or that, in any way, do not respect the requirements stated herein, shall be rejected and deemed ineligible for participation or a prize, as the case may be.
- 11. Disqualification. All persons who participate or attempt to participate in this contest by any means other than those indicated in the present document or by means that are unfair to other participants (i.e. using contest entries that are fraudulently obtained, entering more than once, computer hacking, leveraging group voting, using a fake name, etc.) will be automatically disqualified from the contest and may be reported to the appropriate legal authorities.
- 12. Content process. Any attempt to sabotage the legitimate running of the contest is a violation of civil and criminal law. If some such attempts are successful, the Contest Organizer reserves the right to reject the Participant's contest entry and seek redress under the law.
- 13. Prize acceptance. The prize must be accepted as described in the present document and cannot, under any circumstances, be transferred, in whole or in part, to another person, be substituted by another prize or be exchanged for monetary value, except as provided for in the present rules and regulations.
- 14. Liability. If the Contest Organizer cannot award the prize as described in this present document, they reserve the right to award another prize of the same nature and of equivalent value, or, at their discretion, of the prize value indicated in this present document.
- 15. Liability: Using the prize. The winner releases the Contest Organizer and the parties on whose behalf the contest is held from all responsibilities relating to any injury, loss or damages that may result from participating in the contest or accepting and/or using the prize. The winner also agrees that upon receiving a letter confirming his/her prize, the execution of all obligations relating to the prize become the sole and exclusive responsibility of the various suppliers of products and services. The winner will sign a

Release Form to this effect. The winner also recognizes that the only applicable warranty is the standard manufacturer's warranty.

- 16. Liability: Contest process. The Contest Organizer and the parties on whose behalf the contest is held are released from all responsibility relating to the malfunctioning of any computer components, software or lines of communication, which result in the loss or lack of a network connection, or relating to any faulty, incomplete or incomprehensible transmissions or a transmission deleted by any computer or network, which restricts a participant's ability to read these rules or regulations or enter the contest. They also disclaim any liability for any damages or loss caused, directly or indirectly, in whole or in part, by downloading a web page or software or other and by the transmission of all information relating to participation in the contest. Specifically, if the administration, security, equity, integrity or proper functioning of the Contest is corrupted or severely impacted by, notably, a virus, bug, tampering, unauthorized intervention, fraud, technical failure or for any other cause, the Contest Organizer reserves the right, without prior notice, to cancel, modify, extend or suspend the contest.
- 17. Liability: Submitted entry forms. The Contest Organizer and the parties on whose behalf the contest is held are not responsible for contest entries that are lost, misdirected or submitted late, for any reason whatsoever, including problems relating to the postal service or any failure, for whatever reason, of the website during the Contest Period, including damage to the participant's computer or mobile device.
- 18. Liability: Situations beyond control. The Contest Organizer and the parties on whose behalf the contest is held disclaim any and all liability for all cases in which their inability to act results from a fact or a situation beyond their control, or from a strike, lock-out or any other labour conflict in the facilities of organizations or companies whose services are used to hold this contest.
- 19. Modification of the contest. The Contest Organizer reserves the right, at their sole discretion, to cancel, terminate, modify, or suspend, in whole or in part, the contest if there is any event or human intervention that could alter or affect the administration, security, impartiality or proper functioning of the contest as provided in this present document. In such instance, no liability can be claimed.
- 21. End of contest participation. In the event that, for any reason whatsoever, participation in the contest should be terminated, in whole or in part, before the end date stipulated in the present document, the draw may be made, at the discretion of the Contest Organizer, from all eligible entries duly submitted and received up to the date when contest participation was terminated.
- 22. Prize limit. Under no circumstances will the Contest Organizer be required to award more prizes or award a prize other than the one described in the present document.

- 23. Liability: Contest participation. By participating or attempting to participate in the contest, Participants release the Contest Organizer and the parties on whose behalf the contest is held from any liability for any damages caused by participating or attempting to participate in the contest.
- 24. Authorization. In accepting the prize, the winner authorizes the Contest Organizer and their representatives to use, if required, his/her name, photograph, image, voice, place of residence and/or a declaration relating to the prize for advertising purposes, without any compensation.

- 29. Severability. If a paragraph in this present document is declared or judged to be illegal, unenforceable or invalid by a competent court, this paragraph will be considered void, but all other unaffected paragraphs will be applied to the extent permitted by law.

- 31. This constitutes the official contest rules and regulations. This contest is subject to federal, provincial and municipal laws and regulations. This present document may be modified without prior notice, with the consent of the *Régie des alcools, des courses et des jeux du Québec*, if required, in compliance with all federal, provincial and municipal legislation or with the policies of any other entity having jurisdiction over the Contest Organizer.
